

# **KuulSeats Privacy Policy**

#### Introduction

This Privacy Policy outlines how KuulSeats and its subsidiaries ("we", "our", or "us") collect, use, process, and share personal information. We do not sell or rent your personal information to third parties for marketing purposes without your consent.

#### 5. International Data Transfers

#### 6. Data Retention

We retain your personal information for as long as necessary to fulfil the purposes outlined in this Policy. After this period, we will securely delete or anonymise your data unless otherwise required by law (e.g., for tax or audit purposes).

#### 7. Your Rights

- The right to object to or restrict data processing.
- The right to withdraw consent for certain types of data processing (e.g., marketing).
